#### **Criminal History - County-by-County (Some states vary on turn-around-time)**

Records are accessed via the Clerk of the Courts in the specific county requested.

#### **Wants and Warrants**

A search for criminal wants on an individual for crimes in which an outstanding warrant, capias, or indictment has been issued. The criminal charges are crimes where the federal or state agency will extradite an individual to answer criminal charges.
